**2. Introduction of Bill 1 of 2026**

The Board introduced Bill 1 of 2026, a proposed local law which would amend the Vehicle and Traffic Code of the Village, in relation to parking restrictions in Wheatley Villa. A public hearing will be held on Thursday, February 5, 2026.

**3. Introduction of Bill 2 of 2026**

The Board introduced Bill 2 of 2026, a proposed local law authorizing a property tax levy in excess of the limit established in General Municipal Law §3-C. A public hearing will be held on Thursday, February 5, 2026.

**4. Taco Bell Special Use**

The Board discussed requesting records from the Nassau County Police Department on complaints made at the Taco Bell location, 511 Old Country Road, Westbury, NY. Also, it was discussed that the Planning Board originally approved the special use permit via a site plan which the Building Superintendent was asked to locate following the meeting and in advance of the continued hearing date.

**5. Approval of Claims and Expenditures**

Review and approval of claims and expenditures for the period January 8, 2026 through January 15, 2026 in the amount of \$41,422.26, of which \$41,302.26 was from the General Fund and \$120.00 was from the Capital Fund. Trustee Quintanilla made a motion to submit bills for payment, seconded by Trustee Jefferson. Motion to approve was passed; The Board was polled, all voting “Aye” (5-0).
